

# FINANCIAL ASSISTANCE FOR FURTHER EDUCATION STUDENTS

# 1. PURPOSE

- **1.1** This Policy sets out the arrangements for financial support provided by the Education and Skills Funding Agency (ESFA) 16-19 Bursary Fund for Further Education students, ESFA Adult Education Budget Learner Support Funds (AEB), and the Advanced Learner Loans Bursary Fund (ALLBF) for 19+ learners, for 2022-2023.
- **1.2** Full time students studying on ESFA funded programmes can apply for assistance from funds provided by the Education and Skills Funding Agency.
- **1.3** Part time students studying on ESFA funded programmes may be able to apply for assistance from funds provided by the Education and Skills Funding Agency.

### 2. SCOPE

The Policy outlines arrangements for: 16-19 Bursary Fund for Further Education students, ESFA Adult Education Budget Learner Support Funds (AEB), and the Advanced Learner Loans Bursary Fund (ALLBF) for 19+ learners, for 2022-2023.

# 3. OBJECTIVES

This Policy explains various types of financial assistance available to Further Education students, the eligibility criteria and the appeals process.

#### 4. <u>16 – 19 BURSARY FUND</u>

The bursary fund is to help students with essential costs of participating in their study programme. It is not to provide support for general household incomes. All awards are subject to the student completing an application on PayMyStudent (<u>Blackburn College (paymystudent.com)</u>, providing any evidence requested and outlining their study related costs. Funds will be allocated on a first come, first served basis. Any award decisions will be made based on the actual financial needs of individual students, the availability and the level of household income. Our All About You support package will be based upon your highest priority needs and may consist of different elements of support.

# 4.1 Eligibility

- Household income below £34,000
- Students who are aged 16 18 (be at least 16 but under 19 years of age on 31 August 2022) and satisfy the eligibility criteria set out in the ESFA Funding Guidance 2022/23.
- Students who are 19 or over as at 31 August 2022 and are continuing a study programme they began aged 16-18.
- Students aged 19 who have an Education, Health and Care Plan (EHCP)
- To retain eligibility during the academic year, students must also have a good attendance rate at college of at least 90% and/or be actively engaged in their studies.
- Students must also demonstrate positive behaviour for learning and be making the expected level of progress on their study programme.

- Payments may be withheld if students do not meet the expected attendance and behaviour standards.
- Payments will be stopped where students have been absent for a period of 4 continuous weeks or more.
- Where students withdraw from a study programme, bursary allocations will cease and students may need to return any unused allocations.

#### 4.2 Travel Assistance

Where assistance with travel is identified as an individual need, Blackburn College will use the 16-19 Bursary Fund to support eligible students with the cost of a bus pass to travel to college from their registered home address. The full cost of the pass will be paid from the fund for those students with a household income of under £34,000, who live more than a mile away from college and have made a successful application.

Travel passes will be issued on a termly basis and students must maintain an attendance rate of 90% or above for travel assistance to continue each term. Where attendance falls below this level, a weekly pass may be issued as an alternative.

Please note funds are limited and awards for travel assistance will be made on a first come, first served basis, so we advise students to apply early.

Bus passes will be issued electronically using the Transdev Go App, to the email address used on the PayMyStudent application. If a student does not have a suitable mobile device, alternative arrangements can be made.

#### 4.3 Lunch Card

### Daily Free College Meals

Additional Eligibility Requirement:

Blackburn College will provide a free college meal to the value of £3 per day of timetabled study for students –

- 1. Aged between 16 and 18 on 31 August 2022 who are studying a full-time further education course and are disadvantaged as defined by the students being in receipt of, or having parents who are in receipt of, one or more of the benefits listed below
- 2. Aged 19+ on 31 August 2022 and continuing with a study programme they started prior to being 19, OR, with an Educational Health Care Plan (EHCP), who are disadvantaged as defined by the students being in receipt of, or having parents who are in receipt of, one or more of the following benefits:

# Eligible benefits

- Income Support.
- Income-based Jobseekers Allowance.
- Income-related Employment and Support Allowance (ESA).
- Support under part VI of the Immigration and Asylum Act 1999.
- The guarantee element of State Pension Credit.
- Child Tax Credit (provided you are not entitled to Working Tax Credit and have an annual gross income of no more than £16,190, as assessed by Her Majesty's Revenue and Customs (HMRC)).
- Working Tax Credit run-on.

• Universal Credit with net earnings not exceeding the equivalent of £7,400 pa.

Blackburn College will provide a free college meal to the value of £3 per day of timetabled study. Funding will be added to a student's ID card which can be swiped at payment points at all college food outlets.

#### 4.4 Food Allowance

Where students are not eligible for a Free College Meal but require support with the costs of food and drink during the college day, Blackburn College will provide bursary eligible students with a food allowance of up to £300 per year that can be spent at all College food outlets (dependent on household income). Credit will be uploaded to student ID cards once a term and students need to maintain an attendance rate of 90% or above for credits to be made. Students will need to manage their funding and we expect healthy food choices are made to ensure that funding lasts for the expected term. Blackburn College retain the right to decide when payments of the food allowance will be made.

# 4.5 Kit, Uniform and Books Assistance

Where assistance with essential equipment is identified, Blackburn College will use the Bursary Fund for eligible 16 – 18 further education students so that they can fully participate in class by accessing additional uniform, books and equipment that they are unable to purchase for themselves. Curriculum Centres will advise what kit, uniform or books a student requires and this will be subject to funds availability. Please note, any kit and equipment supplied may need to be returned at the end of a student's studies.

### 4.6 Trips & Visits

Where a trip/visit is an essential part of a student's study programme and the cost is prohibitive to a student's participation, support from the Bursary Fund may be provided. We will need to see evidence of costs and a justification from relevant curriculum staff stating what modules of study the trip/visit relates to and the expected impact the trip/visit will have on the student's learning and achievement. Funds are limited and award decisions will be made based on individual needs.

#### 4.7 UCAS Fees and Open Days

Any bursary eligible 16 – 18 further education student who requires help with the cost of a UCAS fees or the costs of attending open days to explore progression options, can apply for support with those costs. Funding will need to be agreed in advance and Blackburn College retain the right to decide when payments will be made, subject to funds availability.

#### 4.8 Industry Placements

Where additional costs will be incurred which prohibits a student from participating in an industry placement, support may be provided from the Bursary Fund. Funding will need to be agreed in advance, following an individual assessment and Blackburn College retain the right to decide when payments will be made, subject to funds availability.

#### 4.9 Childcare

All learners aged 19 years old and under who require childcare support can access 100% of childcare costs from 'Care to Learn'. Applications are made directly to the scheme on www.gov.uk/care-to-learn

# 5. <u>16 - 18 BURSARY FOR VULNERABLE GROUPS</u>

Students who meet the criteria, and who have a financial need, can apply for a bursary for vulnerable groups. Students will be awarded the amount of support they need to participate based on an assessment of the types of costs they have and will not be automatically awarded a bursary.

# 5.1 Eligibility:

- Students who are aged 16-18 (Be at least 16 but under 19 years of age on 31 August 2022).
- Students must meet the ESFA funding regulations residency criteria
- Students must be defined as being in one of the following vulnerable groups:
- Young people in care, including looked after and unaccompanied asylum-seeking young people.
- Young care leavers
- Young people in receipt of Income Support or Universal Credit.
- Disabled young people in receipt of Employment Support Allowance (or Universal Credit as a replacement for ESA) who are also in receipt of Disabled Living Allowance or Personal Independence Payments.
- To retain eligibility during the academic year, students must also have a good attendance rate at college of at least 90% and/or be actively engaged in their studies.

# 5.2 Awards and Payments

- Vulnerable students will be assessed for an award of up to £1200.
- Award amounts will vary depending on the student's individual financial needs for participation. These will be assessed as part of the bursary application and it is possible that no award or a limited award will be made where there is not a financial need because these are already met and/or they have no relevant costs.
- Awards may include support with travel, a food allowance, support with study related kit and equipment, essential trips and visits, UCAS and university open days and industry placement costs.
- Any other additional costs will be assessed on a case by case basis.
- Payments may be withheld if students do not meet the expected attendance and behaviour standards.
- Payments will be stopped where students have been absent for a period of 4 continuous weeks or more. Where students withdraw from a study programme, bursary allocations will cease and students may need to return any unused allocations.

#### 6. ADULT EDUCATION BUDGET HARDSHIP FUND (NOT ALLBF)

The hardship fund is to help students with a specific financial hardship preventing them from taking part or continuing in learning. It is not to provide support for general household incomes. All awards are subject to the student completing an application on PayMyStudent (<u>Blackburn College (paymystudent.com)</u> providing any evidence requested and details of their study related costs. Funds will be allocated on a first come, first served basis. Any award decisions will be made based on individual needs.

# 6.1 Eligibility

- Students who are aged 19+ as at 31 August 2022 studying an adult funded programme
- Have a household income less than £34,000 (including spouse/partner) and/or in receipt of Universal Credit, Jobseekers Allowance, Income Based Employment Support Allowance, Tax Credit Award or Income Support.
- Satisfy the residency criteria set out in the ESFA AEB Funding Guidance 2022/23.
- Students must continue to satisfactorily attend college at a rate of 90% and above
- Students must also show a good attitude to learning and be making satisfactory progress on their course.
- Support may be withdrawn if students do not meet the expected standards of attendance and behaviour.
- It is the responsibility of any student in receipt of state benefits to inform the Department for Work and Pensions (DWP) about any bursary they receive as this may impact those benefits.

#### 6.2 Travel

Blackburn College may use the Adult Education Budget Hardship Fund for eligible 19+ Further Education students to subsidise the cost of travel. This may be provided in the form of a bus pass or a travel grant and will be based on individual needs, up to a maximum of £500. Transport funds are limited and will be made available to those students travelling more than one mile into college, on a first come, first served basis.

# 6.3 Kit, Uniform and Books

Blackburn College will use the Adult Education Budget Hardship Fund for eligible 19+ Further Education students so that they can fully participate in class by accessing additional uniform, books and equipment that they may not have been able to purchase themselves. Curriculum Centres will advise what kit, uniform or books a student requires.

#### 6.4 Food Allowance

Blackburn College will provide bursary eligible 19+ Further Education students who have a need for support with food and drink during the college day, with a food allowance that can be spent at all college food outlets (dependent on household income). Credit will be uploaded to student ID cards once a term and students need to maintain an attendance rate of 90% or above for credits to be made. Students will need to manage their funding and we expect healthy food choices are made to ensure that funding lasts for the expected term. Blackburn College retain the right to decide when payments of the food allowance will be made.

#### 6.5 Trips & Visits

Where a trip/visit is an essential part of a student's study programme, students can apply to the bursary fund for a contribution towards these costs. We will need to see evidence of costs and a justification from relevant curriculum staff stating what modules of study the trip/visit relates to and the impact on learning and achievement. Funds are limited and award decisions will be made based on individual needs.

### 6.6 Domestic Emergencies

Support may be provided for domestic emergencies. This will be assessed on an individual basis and you will need to meet with a Student Finance Adviser who will advise you about any additional evidence required.

#### 6.7 Examination Fee

Blackburn College will use the Learner Support Hardship Fund for eligible 19+ Further Education students to pay any examination fees associated with their course.

#### 6.8 Childcare

Additional Eligibility Requirement:

- Student must live alone or with a partner who is employed at the same time as the student's timetable
- Childcare must be from an Ofsted registered childcare provider
- Student must utilise at least 50% of their free government funding hours if applicable.

Blackburn College will use the Learner Support Childcare Fund for eligible Further Education students age 20 and above to pay 90% of all childcare costs to cover timetabled classes during term time only.

# 7. ADVANCED LEARNER LOANS BURSARY FUND

The bursary fund is to help students with a specific financial hardship preventing them from taking part or continuing in learning. It is not to provide support for general household incomes. All awards are subject to the student completing an application on PayMyStudent, providing any evidence requested and outlining their study related costs. Funds will be allocated on a first come, first served basis. Any award decisions will be made based on individual needs.

#### 7.1 Eligibility

- Students who are aged 19+ as at 31 August 2022 studying a programme funded by a loan approved by SLC
- Have a household income less than £34,000 (including spouse/partner) and/or in receipt of Universal Credit, Jobseekers Allowance, Income Based Employment Support Allowance, Tax Credit Award or Income Support.
- Satisfy the residency criteria set out in the ALLBF Funding Guidance 2022/23.
- Students must continue to satisfactorily attend college at a rate of 90% and above
- Students must also show a good attitude to learning and be making satisfactory progress on their course.
- It is the responsibility of any student in receipt of state benefits to inform the Department for Work and Pensions (DWP) about any bursary they receive as this may impact those benefits.

#### 7.2 Travel

Blackburn College may use the Adult Education Budget Hardship Fund for eligible 19+ Further Education students to subsidise the cost of travel. This may be provided in the form of a bus pass or a travel grant and will be based on individual needs, up to a maximum of

£500. Transport funds are limited and will be made available to those students travelling more than one mile into college, on a first come, first served basis.

#### 7.3 Kit, Uniform and Books

Blackburn College will use Advanced Leaner Loans Bursary Fund for eligible 19+ Further Education ALLBF students so that they can fully participate in class by accessing additional uniform, books and equipment that they may have not been able to purchase themselves. Curriculum Centres will advise what kit, uniform or books a student requires.

#### 7.4 Food Allowance

Blackburn College will provide bursary eligible 19+ Further Education students who have a need for support with food and drink during the college day, with a food allowance that can be spent at all college food outlets (dependent on household income). Credit will be uploaded to student ID cards once a term and students need to maintain an attendance rate of 90% or above for credits to be made. Students will need to manage their funding and we expect healthy food choices are made to ensure that funding lasts for the expected term. ### 7.5 Trips & Visits

#### 7.6 Domestic Emergencies

Support may be provided for domestic emergencies. This will be assessed on an individual basis and you will need to meet with a Student Finance Adviser who will advise you about any additional evidence required.

#### 7.7 Childcare

Additional Eligibility Requirement:

- Student must live alone or with a partner who is employed at the same time as the student's timetable
- Childcare must be from an Ofsted registered childcare provider
- Student must utilise at least 50% of their free government funding hours if applicable.

Blackburn College will use Advanced Leaner Loans Bursary Fund for eligible Further Education students aged 20 and above to pay 90% of all childcare costs to cover timetabled classes during term time only.

# 8. <u>16-18 & 19+ APPRENTICES</u>

In line with Government eligibility criteria, apprentices are excluded from receiving any support from these funds.

### 9. APPEALS

If a student does not agree with any decision taken by Student Finance in relation to judgements made on the distribution of support funds then they can make an appeal in writing. These should be addressed to the Assistant Principal for Student Support and Experience at Blackburn College. Students will receive a response and a decision within 10 days of the appeal.

# 10. STAKEHOLDER CONSULTATION

This policy has been devised in accordance with the funding rules and guidance provided by the Education and Skills Funding Agency. Blackburn College's records are audited annually against these guidelines.

# 11. MONITORING AND REVIEWING

- **11.1** The Policy will be reviewed by the College annually in line with the guidance published by the Education and Skills Funding Agency
- **11.2** Annual monitoring of the process takes place by both internal and external auditors, and by regular (termly) monitoring meetings with the Head of Finance and the Vice Principal: Finance and Corporate Services.
